

# LINDA BARKER PAINTS

## PRODUCT ADVICE

### CLASSIC EGGSHELL

#### Where to use:

Interior walls, ceilings, woodwork & melamine – washable multi-surface eggshell - particularly kitchens and bathrooms and other areas where steam and condensation are a problem. Linda Barker Classic Eggshell gives a washable low sheen finish. Self-undercoating - for ply, MDF, melamine, woodwork etc – not floors.

#### Availability:

In 1, 2.5 and 5 litre cans in all 90 colours plus colour matching.

Coverage: Up to 60 m<sup>2</sup> per 5 litres/per coat – normally 2 coats needed.

Drying time: Touch dry in 1 – 2 hours, recoat after min 4 hours, ideally 8+ hours.

Sheen level: 9.6%

#### Preparation:

Surfaces should be sound, clean, dry and free from grease. Prime bare plaster & plasterboard with a plaster-sealer or a water-diluted mist coat of this paint – approx 15% water addition. Lightly abrade woodwork, melamine etc to provide a key. Seal fillers first.

#### Painting:

Do not paint in temperatures below 5°C or direct sunlight or excessive heat above 30°C.

Please check for correct product and colour prior to use as we will not be held liable for issues caused as a result of an incorrect colour or product being applied. Our limit of liability does not exceed the value of our product.

Stir thoroughly before use.

DO NOT THIN. Apply with a good quality fine pile roller or quality fibrillated brush. Do not layoff – always keep a wet edge. Do not go back over painted areas. Do not over spread. Best results are normally achieved with two coats. Although hard, Do not scuff, scrape, wet or wash for 10 days as the product is still hardening.

Airless Spraying – Good results can be achieved by the set up of 18 thou 65° angle tip using a pressure of between 2000 - 2700 psi.

Clean up: Clean brushes and rollers with warm soapy water.

#### Maintenance

Wipe gently with a soft damp cloth or sponge. Do not use harsh, abrasive or alkaline cleansers.

#### Storage:
